### 1. Message from the President:

Since the summer issue, a number of scientific meetings have been held gathering our colleagues of different countries. We've been in the USA to attend the 120<sup>th</sup> annual meeting of the American Academy of Insurance medicine in Chicago. As usual, the meeting was perfectly organized, including two pre-conference courses (introduction to insurance medicine and Basic Mortality Methodology), an outstanding scientific program mixing lectures and workshop. The AAIM President, Dr Clifford Hale and his Bureau organized a splendid meeting and the attendees were lucky enough to have wonderful weather, not too windy in spite of Chicago's nickname: the Windy city.

We have been honored to be invited by Dr Tomohito Shirouzu, President of the Japanese Assurance Medical Society (ALIMJ), to give a lecture at the occasion of the annual meeting of the society, held in Tokyo, Oct.15-17. Though the meeting is held in Japanese, we appreciated the warm welcome of our Japanese colleagues and the perfect organization as well as the high scientific level of the discussed topics.

## 5. **International News**

### 5.1 **AIMA (Asia)**:

The Eighth Scientific Conference of the Academy of Insurance Medicine of Asia (AIMA VIII) was held at Shanghai from 16–19 October 2011.

Four hundred and sixty six delegates from one hundred and forty different life and health insurance companies from the Asia Pacific region attended this conference.

Twenty six papers that were related to both underwriting as well as claims aspects of insurance medicine were presented at this conference by speakers who came from various parts of the world including USA, UK, Sweden, Germany, Canada, China, Hong Kong, Australia, South Africa and France.

The next AIMA conference (**AIMA – IX**) will be held at Taipei, Taiwan in September/October 2013. Further details with regards to this conference will be made available on the AIMA website at <http://www.aimaconference.com>.

### 5.3 **AAIM (USA)**:

The last AAIM conference was held recently from October 1 to 5 in Chicago. It was well attended, and topics covered included an update on aging in America, treatment of heart failure in the elderly, bladder- and thyroid cancer, MS, NASH, benign brain tumours, CAD, cutaneous lymphoma and e-GFR. Two interactive workshops were also hosted on ECG's and echocardiograms.

AAIM's 2012 meeting will be in Dan Diego, California, 13-18 October, 2012 at the Hilton La Jolla Torrey Pines Resort (terrific golf course nearby). It will be AAIM's triennial meeting, which is designed as a broad review of Insurance Medicine.

### 5.4 **AMUS (UK)**:

The summer has been a quiet period for the academic side of Insurance Medicine in the UK.

The feedback from colleagues at a recent meeting of our Society, AMUS, was that the Lucid 2 conference, held over two days in Cardiff, Wales, was well received and hopefully was a financial success.

We had a meeting at the RAF Club in Piccadilly, London, starting, obviously, with the drinks bar opening at 5.30pm and followed by a very good lecture. It was a great pleasure to greet Fabrice Chouty and Dr Camus who came over from Paris on Eurostar.

The address was on "Abdominal Aortic Aneurysms - A Silent Killer: Recent Developments and their Implications". Essentially, a national ultra-sound screening programme for the detection of abdominal aortic aneurysms is being introduced next year for 65 year old men, women do not have the same risk. Treatment, for a better prognosis, is for open surgery in "fit" patients. The "unfit" patients, patients with vascular disease elsewhere, diabetes, obesity, hypertension, raised cholesterol, etc, have endovascular sleeves inserted, sometimes wire loops to cause the aneurysmal sac to thrombose, leaving enough blood to keep the circulation in the legs intact. It was clear from Professor Chris Imray, a very experienced surgeon and speaker, that endovascular treatments were prone to more complications, which is not surprising as they are worse risk patients and clearly not a good insurance risk at any time! It was stressed that endovascular treatments are very expensive, something for medical expenses insurers to consider!

Interestingly, it is evident from data from the UK and relevant to Insurance Medicine, there has been interest shown by underwriters and actuaries in large case underwriting to request ultrasound examination of the abdomen to exclude abdominal aneurysm formation. In Insurance Medicine terms we have been able to use good quality scientific data to show that in the UK aneurysms do not really start to be a problem under the age of 65, and about 5 years earlier for the smoking population. A normal ultrasound examination at 65 means that no other screen for aneurysm is required.

As ultrasound examinations are expensive and inconvenient to proposers we have not included this in high value cases as a routine.

Our next meetings are in March 2012 for the AGM, May, September and November.

5.5 **AMCAP:** Fabrice Chouty

There'll be on December 2, the annual cocktail party of the society, held in Paris and gathering the AMCAP members and some personalities from Life insurance and reinsurance business, and from the world of Law and medical science.

The next scientific meeting (held in French) will take place in Paris on June 8<sup>th</sup> 2012 and the final program will be set until the next few weeks and available on the website of the society (<http://amcap.blogspot.com/>).

As every year, AMCAP will provide volunteers as a teaching support for the Life Insurance Medicine diploma of the University of Marseille.

5.6 **ASISA and SASIMU (South Africa):** Pieter Coetzer

Two successful SASIMU meetings were held recently. The Johannesburg branch was addressed by an actuary on the topic of mortality, and the Cape Town chapter received feedback on the last AHOU conference in Las Vegas in the USA. Both were well attended by underwriters and medical advisors.

5.7 **ANZIMA (Australia):** Detloff Rump

This time, there is nothing to report on IMOK (India), ANZIMA (Aus/NZ), or from elsewhere in Asia-Pacific. AIMA staged a very successful conference in Shanghai recently.

ANZIMA appears to be in winding down mode, which is regrettable.

#### 5.8 **AIMAV (Italy)**

As usual since four years now, Aimav held their annual meeting in Milan on 11 October with the participation of physicians, actuaries, underwriters and liquidators.

Our meetings have replaced the Congresses, now too expensive in view of the current economic crisis, and have become "training days on risk assumption and claim management" in order to be more useful to the participants in the performance of their daily work.

The theme this year was "Long term care policy", which is popular currently in Italy, and it has been studied from a strictly insurance point of view (with papers by underwriters, actuaries and liquidators), and from a medical perspective, aimed to those pathologies (acute and chronic) which may involve the loss of autonomy, with the intervention of specialists in neurology and rehabilitation medicine.

The working day was a great success, with approximately a hundred registered people and with interventions aimed at improving the knowledge of the topic.

At the end of the working day we had the AIMAV Board Meeting, resulting in the reconstitution of the Board, the appointment of a new Chairman in place of the late Prof. Ferdinando Antoniotti, and the confirmation of the three Vice-Presidents (an actuary, a specialist in forensic medicine and a consultant at a leading Insurance Company), and the General Secretary.

The new Chairman of Aimav is Prof. Colomba Calcagni, Prof. Antoniotti's widow, who is Director of the Association by many years, and Professor of Forensic and Insurance Medicine at the University of Rome.

#### 5.10 **EUMASS (Europe):**

The XIXth EUMASS Congress will take place from the 14th to the 16th of June 2012 in Padova. The city lies on the River Bacchiglione in the North-East of Italy and is linked to Venice by the River Brenta. Padova is internationally

known for its University, the second oldest in the world after Bologna. It was founded in 1222 as some professors left Bologna to find more freedom in teaching, and in 1250 the first School of Medicine was created.

The EUMASS Congress will be organised with the cooperation of the National Institutions of Social Security such as INAIL and INPS (Workers' Compensation Authority and Sickness and Invalidity Insurance Fund). The opening ceremony will take place in the Great Hall (Aula Magna) of the University and the other sessions will continue in the Conference Centre of the Town Hall.

The title of the Congress will be: "Social security challenges in Europe". The Scientific Committee, provisionally, proposes the following themes:

- Population and work force challenges in Europe.
- A healthy worker in a healthy workplace.
- Evidence based benefit decisions.
- Return to work: what works?
- The influence of e-health on healthcare.
